for the Extraordinary General Meeting ("EGM") of KPJ Healthcare Berhad ("KPJ" or the "Company")

Entitlement to Participate and Appointment of Proxy

- 1. No members/proxies/corporate representatives from the public will be allowed to be physically present at the premises of the Company, the poll administrator or the venue where the Chairman will be for the purpose of the EGM.
- 2. In respect of deposited securities, only a depositor whose name appears in the Record of Depositors as at **21 February 2025** shall be eligible to attend the EGM or appoint proxy(ies) or corporate representative to attend and/or vote in his/her stead.
- 3. As shareholders, please register your attendance and exercise your rights as shareholders at the EGM remotely using the aforesaid RPV facilities. If you are appointing a proxy or corporate representative to attend, participate, speak and vote on your behalf, please request your proxy or corporate representative to register himself/herself for the aforesaid RPV facilities in accordance with the procedures set out below.
- 4. If you are unable to attend the EGM, you are encouraged to appoint a proxy or the Chairman of the meeting as your proxy. Please indicate your voting instructions in the Proxy Form.
- 5. If you wish to attend the EGM yourself, please do not submit any Proxy Form for the EGM. You will not be allowed to attend the EGM together with the appointed proxy.
- 6. Accordingly, Proxy Forms and/or documents relating to the appointment of proxy/corporate representative for the EGM whether in hard copy form or by electronic means shall be deposited or submitted in the following manner at least forty-eight (48) hours before the time appointed for holding the EGM i.e. not later than **Wednesday**, **26 February 2025** at **3:00 p.m.**:
 - (a) <u>In hard copy form</u>

In the case of an appointment made in hard copy form, the Proxy Form must be deposited with the poll administrator of the Company at Unit 32–01, Level 32, Tower A, Vertical Business Suite, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur, Malaysia or alternatively, Drop-in box at Unit G-2, Ground Floor, Vertical Podium, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur, Malaysia.

(b) <u>By electronic form</u>

The Proxy Form can be electronically lodged with the poll administrator of the Company via TIIH Online website at <u>https://tiih.online</u>. The steps to submit your Proxy Form via TIIH Online are summarised under item 13A(c) below.

Poll Voting

- 7. The voting at the EGM will be conducted by poll pursuant to Paragraph 8.29A(1) of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad ("Bursa Securities"). The Company has appointed Tricor Investor & Issuing House Services Sdn Bhd ("Tricor") to conduct the poll voting electronically ("e-voting") via Tricor e-Vote application ("Tricor e-Vote App") and Deloitte Business Advisory Sdn Bhd as Independent Scrutineers to verify the poll results.
- 8. Members/proxies/corporate representatives can proceed to vote on the resolution at any time from the start of the EGM at 3:00 p.m. on Friday, 28 February 2025 until the time when the Chairman announces the closure of the voting session at the EGM. Kindly refer to item 13B(c) below for guidance on how to vote remotely via TIIH Online.
- 9. Upon closure of the voting session for the EGM, the scrutineers will verify the poll results, followed by the Chairman's declaration of the poll results.

RPV Facilities

- 10. The RPV facilities are available on TIIH Online website at <u>https://tiih.online</u> or <u>https://tiih.com.my</u> (Domain registration number with MYNIC: DIA282781).
- 11. Members/proxies/corporate representatives are to attend, speak (in the form of real-time submission of typed text) and vote remotely at the EGM using the RPV facilities of TIIH Online.
- 12. Questions may be submitted before or during the EGM using the RPV facilities. The Board or Management of the Company will endeavour to respond to your questions during the EGM.

Procedures to Participate and Vote Remotely Using TIIH Online

(b) Submit your request to attend the EGM remotely	 Registration is open from Thursday, 6 February 2025 at 9:00 a.m. until the day of the EGM on Friday, 28 February 2025. Access the website at https://tiih.online. Login with your user ID (email address) and password. Select the Corporate Event: "(Registration) KPJ Healthcare Berhad EGM 2025". Read and agree to the Terms and Conditions and confirm the Declaration. Select "Register for Remote Participation and Voting". Review your registration and proceed to register. System will send an email to notify that your registration for remote participation is received and will be verified. After verification of your registration against the Record of Depositors as at 21 February 2025, the system will send you an email after 26 February 2025 to notify the approval or rejection of your registration. Should your application to join the EGM be approved, we will make available to you the rights to join the meeting and to vote remotely. Your login to TIIH Online on the day of meeting will indicate your presence at the virtual meeting.
(c) Submission of Proxy Forms and/or documents relating to the appointment of proxy/corporate representative/ attorney electronically	 The Proxy Form is to be lodged at least forty-eight (48) hours before the meeting i.e. before Wednesday, 26 February 2025 at 3:00 p.m. Steps for Individual Shareholders Access the website at https://tiih.online. Read and agree to the Terms and Conditions and confirm the Declaration. Insert your CDS account number and indicate the number of voting shares to be represented by your proxy(ies). Indicate your voting instructions – FOR or AGAINST. Otherwise, your proxy will vote on your behalf. Review and confirm your proxy(ies) appointment. Print the Proxy Form for your record.

(b) Participate online	 Select the Corporate Event: "(Live Stream Meeting) KPJ Healthcare Berhad EGM 2025" to engage in the proceedings of the meeting remotely. If you have any questions for the Board of Directors/Management of the Company, you may type your questions in the "Query Box" (on the right-hand side of your screen) and click "Submit". The Board of Directors/Management of the Company will endeavour to respond to your questions during the EGM. (Note: The quality of your connection to the live streaming is dependent on the bandwidth and stability of the internet connection at your location and the device you use)

B. On the EGM Day (28 February 2025) (Cont'd)

(c) Online remote voting	• You may vote at any time from the start of the EGM at 3:00 p.m. until the time when the Chairman announces the closure of the voting session at the EGM.
	 Select the corporate event. (Remote voting) KPJ heathcare Berhad EGM 2025" or if you are on the live stream meeting page, you can select "GO TO REMOTE VOTING PAGE" button below the Query Box.
	• Read and agree to the Terms and Conditions and confirm the Declaration.
	• Select the CDS account number (tick the box) that represents your shareholdings.
	 Indicate your votes for the resolutions that are tabled for voting. Review your votes cast and click "Confirm" to submit your votes. You may choose to download document (of your votes) for record.
(d) End of remote participation	• Upon the announcement by the Chairman on the closure of the EGM, the live streaming will end.
